

Since Cr(VI) may not be uniformly distributed in the coating even within the same sample batch, a "grey zone" between 0.10 $\mu\text{g}/\text{cm}^2$ and 0.13 $\mu\text{g}/\text{cm}^2$ has been established as "inconclusive" to reduce inconsistent results due to unavoidable coating variations. In this case, additional testing may be necessary to confirm the presence of Cr(VI). 
